The Judges have completed the **OCTOBER 18, 2021** civil jury term and the November 2021 Special Listings. Two civil cases reached verdict and the summaries are as follows:

THOMAS WOROSZ, JR., v. RALPH STEVENS (2018 CV 02945 CV)

Trial dates: October 18-19, 2021

Trial Summary: This case arose out of a motor vehicle accident which occurred on May 10, 2016, on Susquehanna Trail. Defendant Stevens turned his vehicle onto the roadway to travel north and collided with Plaintiff Worosz' vehicle.

The parties stipulated to Defendant's liability. They proceeded to trial on the issue of damages and disputed the nature and extend of Plaintiff's injuries related to the accident.

Plaintiff's expert asserted that Plaintiff suffered a lumbar sprain and strain, cervical sprain and strain, abdominal strain and sprain, interior chest wall contusion and mechanical instability of the knee. Plaintiff sought damages for pain and suffering and reimbursement of medical expenses.

Defendant's expert disputed causation of injuries only as to the mechanical instability of the knee.

The verdict slip required the jury to make separate findings as to the factual causation of the alleged injuries.

Verdict: The jury found that the accident caused Plaintiff's lumbar sprain and strain, cervical sprain and strain, abdominal strain and sprain, interior chest wall contusion but not the mechanical instability of the knee. The jury awarded total damages of \$8,000.

CLYDE AND ZULMIRA ARBEGAST v. HERSHEY MEDICAL CENTER AND AMY REED, M.D.
(2016-CV-08769-MM)

Trial dates: November 1-4, 2021

Trial Summary: Plaintiff Clyde Arbegast had knee surgery at the VA Hospital and due to complications of a foot drop, was transferred to Hershey Medical Center. Defendant Amy Reed, M.D. was the treating physician at Hershey. Dr. Reed did a workup and performed surgery fifteen hours after his admission to Hershey Medical Center. The bypass to correct the foot drop was unsuccessful.

Plaintiff's expert vascular surgeon was Paul Collier, M.D., who opined that the delay increased the risks of a bad outcome.

The defense expert vascular surgeon was Roman Nowygrad, M.D., who opined that by the time the Plaintiff got to Hershey, there was no chance of reversing the foot drop.

Prior to trial, the Plaintiff had settled in a separate lawsuit against the VA Hospital.

Verdict: For Defense. On the multi question verdict form, the jury answered question number 1 as to negligence – NO.

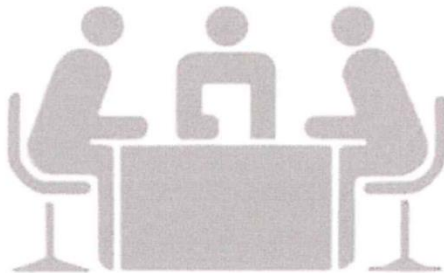
