A birth relative is defined only as a parent, grandparent, stepparent, sibling, uncle or aunt of the adoptive child, whether the relationship is by blood, marriage or adoption. This voluntary agreement may allow you to have continuing contact or communication, including, but not limited to: Letters and/or emails; Photos and/or videos; Telephone calls and/or text messages; or Supervised or unsupervised visits.
