**The Judges have completed the January 2022 civil jury term and the February 2022 Special Listing. Two civil cases reached verdict and the summaries are as follows:**

**MARILYN RICH and RANDAL RICH, wife and husband v. MALIK N. MOMIN, M.D.; SUSQUEHANNA VALLEY PAIN MANAGEMENT, P.C.; HOLY SPIRIT HOSPITAL OF THE SISTERS OF CHRISTIAN CHARITY, INC., t/d/b/a GEISINGER HOLY SPIRIT HOSPITAL; LEROY KARL RUNG, PA-C; and SPIRIT PHYSICIAN SERVICES, INC., t/d/b/a GEISINGER HOLY SPIRIT MEDICAL GROUP (2019 CV 07132 MM)**

**Trial dates:** January 31 - February 3, 2022

**Background:** In August 2018, while helping her husband move items in his classroom, Mrs. Rich injured her back moving a mini fridge. Her pain persisted and her family physician referred her to Dr. Momin at SVPM. On September 7, 2018, Dr. Momin's physician's assistant examined her and recommended an epidural steroid injection (ESI). Mrs. Rich underwent the procedure on Tuesday September 11, 2018, performed by Dr. Momin. Two days later, Mrs. Rich telephoned Dr. Momin to report that her pain had increased dramatically. She was told to give the injection time. By the next day, she experienced bilateral numbness from her waist down and needed a rolling walker to ambulate. She again called Dr. Momin and was again told to give the injection more time, and asked to schedule a second injection.

Mrs. Rich's condition worsened and by the next Tuesday morning, September 18, Mrs. Rich had to use a wheelchair. She telephoned Dr. Momin's office at 9 a.m. and her message was relayed to the physician's assistant who determined, under office protocol, that it was not an emergency or urgent situation requiring that Dr. Momin be immediately contacted, but was something that could wait. As such, Dr. Momin did not receive Mrs. Rich's message until later in the day and he contacted Mrs. Rich around 4 p.m. He instructed her to go to the hospital emergency department.

Mrs. Rich went to the Holy Spirit ER on the evening of September 18. Even though cauda equina syndrome was suspected, which required immediate attention, Mrs. Rich was nevertheless instructed to go home and see neurosurgeon Dr. Sheehan the next morning. Mrs. Rich was examined by Dr. Sheehan at approximately 10:45 a.m. and Dr. Sheehan immediately sent her to Holy Spirit Hospital for immediate surgery to decompress her lumbar spine.

Plaintiffs assert that the Defendants' delay in diagnosing her cauda equina symptoms and failure to order immediate surgical decompression cost Mrs. Rich her best chance to fully recover and she continues to have difficulty ambulating due to numbness and weakness in her legs, back pain, inability to sense the need to urinate or defecate, and inability to perform sexually. She brought this action, along with her husband, against Dr. Momin and naming SVPM as liable vicariously for Dr. Momin's negligence. The Plaintiffs also sued Holy Spirit Hospital, the neurological practice and other staff, that were consulted the night of September 18. Mrs. Rich sought only general non-economic damages; she did not seek wage loss nor past medical expenses. Mr. Rich sought damages for loss of consortium.

Prior to trial, the Plaintiffs and the Geisinger Holy Spirit Defendants reached a settlement and entered a stipulation releasing them from the action. Those Defendants nevertheless participated in the trial and were included on the verdict slip.

At trial, Dr. Momin's primary defense was that he did not breach the standard of care in causing a surgical delay because he did not receive Mrs. Rich's message from the morning of September 18 until late in the day and that once he received it, he acted immediately. To the extent SVPM staff were allegedly negligent for causing a delay, including the physician's assistant, they had not been named in the Complaint and Dr. Momin was not responsible for their alleged inaction.

Khatiwada, asserting misdiagnosis by the Defendants of an emergent aortic dissection leading to allegedly unnecessary open-heart surgery.

On October 21, 2018, Plaintiffs arrived in Harrisburg on a flight from Fargo, N.D., to visit family. At the time of landing, 31-year-old Man Karki began having shortness of breath and difficulty breathing. An ambulance transported him to UPMC Harrisburg Hospital. A CTA scan of his chest was done around 1:08 p.m. and Defendant Dr. Moyer, a radiologist (with Defendant Quantum Imaging), interpreted the scan around 2:06 p.m. as showing an "age-indeterminate aortic dissection."

Cardiothoracic surgery was consulted a few minutes later. Defendant Dr. Loran, a cardiothoracic surgeon (with the UPMC Pinnacle Defendants), reviewed the chest CTA scan and agreed with Dr. Moyer that it revealed an aortic dissection. There were no follow up imaging studies undertaken by the Defendants. Drs. Moyer and Loran discussed their findings with Mr. Karki and his wife, informing them that if he did not have immediate surgery, the condition could be fatal. Mr. Karki, who had no past cardiac history, was shocked by the seriousness of the situation had very little time to consent to surgery.

At 4:19 p.m., Dr. Loran performed open heart surgery to repair the dissected aorta but discovered no dissection and that Mr. Karki's heart was fine. Mr. Karki was taken off the bypass machine, the heart was given time to recover, drainage tubes were placed in his chest, the sternum was closed and the fascia incision closed.

Mr. Karki developed some post-operative complications and was discharged on October 26, 2018, after a five (5) day stay. He returned to the hospital two days later with shortness of breath and palpitations. His EKG was normal, his pain related to the sternotomy and he was sent home. Mr. Karki continued to struggle with chest pain and shortness of breath.

Plaintiffs asserted that both doctors negligently interpreted the CTA scan and that a line on the imaging represented a benign motion artifact (distortion caused by heartbeat). Both sides produced expert testimony supportive of their positions as to whether the CTA interpretations were reasonable and whether other studies could or should have been conducted.

During Mr. Karki's hospital admission, two non-parties, radiologists Drs. Otto and Goodman, reviewed the initial CTA study. Neither were involved in CTA interpretation prior to surgery; however, they reviewed the studies contemporaneously with Mr. Karki's care.

Dr. Otto accidentally read and interpreted the original CTA scan, when he was supposed to read the post-op chest x-ray and wrote an addendum to the original Chest CTA Scan report, on the evening of Mr. Karki's surgery, stating: "No aortic aneurysm or dissection. Motion artifact is seen at the ascending aorta."

Dr. Goodman recalled that he was asked to review the pre-surgical CTA scan but did not recall who made the request and he did not make any notes about his review. He testified that he interpreted the line on the scan as an aortic dissection, requiring emergency surgery.

**Pre-Trial Rulings:** Prior to trial, the Court entertained Plaintiffs' motion in limine seeking to preclude, as duplicative, cumulative and/or irrelevant, any testimony from Dr. Goodman about whether the CT scan was correctly read. In their joint response, Defendants argued that any evidence and testimony from both Drs. Goodman and Otto should be precluded at trial. The Court issued its order January 7, 2022, denying the motion to preclude Dr. Goodman's testimony although the Court directed that his testimony be limited to that of a fact witness only, as he did not review CT scan for treatment purposes or forming an expert opinion. The Court further ruled that Dr. Otto could express his contemporaneous interpretation that he observed a motion artifact within the confines of his notations in the relevant medical records.
