The Judges have completed the April 2022 civil jury term. One civil case reached verdict and the summary is as follows:

BETSY GOODMAN and CHRISTOPHER GOODMAN, her husband v. ROGER J. LEVIN, M.D., and ASSOCIATED OTOLARYNGOLOGISTS OF PENNSYLVANIA, INC. (2018 CV 00086 MM)

Trial dates: April 3 – April 8, 2022

Background: This medical malpractice action was instituted by Plaintiff Betsy Goodman against Defendants Dr. Roger Levin and his practice, Associated Otolaryngologists of Pennsylvania, Inc. Plaintiff alleged that Dr. Levin, an otolaryngologist, negligently performed thyroidectomy surgery, resulting in permanent damage suffered to Plaintiff's left recurrent laryngeal nerve. Plaintiff alleged that Dr. Levin did not suitably protect the left recurrent laryngeal nerve during surgery, thereby permanently injuring this nerve as well as the parathyroid gland. Plaintiff's expert testimony was that Dr. Levin improperly performed a total thyroid surgery which was reflected in later testing that showed there was no thyroid tissue left.

Plaintiff alleged that Associated Otolaryngologists was vicariously liable for Dr. Levin's negligent conduct.

Dr. Levin claimed that Plaintiff was informed that a potential risk of a thyroidectomy was nerve damage, and fully consented to the procedure. Dr. Levin further claimed that he took standard precautions to protect the nerve during surgery and disputed that postoperative imaging reflected that he took out the entire thyroid without dissecting out the nerve. His experts testified that surgery was not a total removal but was sub-total, and presented postoperative imaging that showed residual thyroid tissue, which atrophies over time in the setting of surgical vascular disruption and thyroid replacement therapy. Dr. Levin's contemporaneous notes also reflected that he claimed to have performed a sub-total removal.

As a result of the surgery, Plaintiff suffered from difficulty with breathing, swallowing, and speaking. She has undergone repeated stroboscopy procedures to assess the extent of damage to the left recurrent laryngeal nerve, as well as protracted physical therapy for voice training and respiratory re-training. Plaintiff also asserted that she is reliant on medications to control her calcium level as related to the hypocalcemia she developed following surgery.
