

### 2025 JUSTICE THURGOOD MARSHALL FELLOWSHIP APPLICATON

The Justice Thurgood Marshall Fellowship is a program of the Dauphin County Bar Foundation. The fellowship was founded by the former Keystone Bar Association, which was first organized as the Harrisburg Black Attorneys Association.

## **Requirements & Eligibility.**

The Thurgood Marshall Fellowship is open to third year law students and recent graduates of any ABA Accredited Law School who have secured employment located in

Dauphin County in a law firm, government agency, legal non-profit, or other public interest employment related to the legal profession AND who also are members of an under-represented racial or ethnic group in the legal profession. Recipients must be members of the Dauphin County Bar Association.

Fellowships will be awarded based on the recipient's potential for making a contribution to society and the legal profession through current or anticipated legal efforts. An essay of up to 1,000 words that articulates how the applicant meets these criteria is required.

### Award.

One fellowship is awarded each year, and each fellowship is disbursed in up to three, \$1000 installments:

- At the start of employment, after the recipient's selection;
- After 12 months of continued employment, with verification from a supervising attorney, hiring manager, or equivalent.
- After 24 months of continued employment, with verification from supervising attorney, hiring manager, or equivalent.

Each fellowship concludes 24 months after the initial disbursement.

# Submission.

Submit the completed application form, final law school transcript (unofficial), resume, and required essay by U.S. Mail or email on or before **October 30, 2025**. Late applications will not be accepted.
