Chris went onto college and received her B.A. in Business Management from the State University at Albany and embarked on a career in Retail Management with Thom McAn Shoes that lasted 15 years. That job not only gave her a lifetime infatuation with shoes, but sparked her interest in the law. When seeking a change of career, that same legal spark caught fire with Chris as she became employed in the law profession and began work as a paralegal. She furthered her education and in 1993, she received her Juris Doctorate at Widener University.
