

MEMORIAL RESOLUTION
UPON THE DEATH OF
ROBERT A. ENDERS

Robert Allen Enders, Sr., Esquire, passed away on August 18, 2008, in his home in Susquehanna Township, with his wife of 59 years, Vivian Graupner Long Enders, by his side.

Robert Enders was an attorney in the Harrisburg area for over 50 years and was president and owner of Susquehanna Title Agency, Inc. He was born in Harrisburg, Pennsylvania, on December 15, 1922. He was a graduate of John Harris High School, Dickinson College and Dickinson School of Law. After law school, he clerked for the late Judge Paul G. Smith and the late Judge R. Dixon Herman and then became a sole practitioner with a focus on real estate and title matters.

During World War II, Lt. Robert Enders was a Corsair fighter Pilot with the United States Marine Corps in the Pacific. His gentle and unassuming manner belied his passion for serving as a fighter pilot and being forced to bale out of his plane over New Guinea.

Robert was a member of and active in the Pennsylvania and Dauphin County Bar Associations. He served as Director of the Pennsylvania Bar Insurance Fund, Vice Chairman of the Pennsylvania Real Property Committee, Director of the Dauphin County Tax Claim Bureau and was a long time associate of Mid-Penn Bank, Millersburg, PA.

He was a member of Grace United Methodist Church, Harrisburg, and a long time member of the Country Club of Harrisburg where he enjoyed many hours of golf. Among his golfing friends were Attorney Health Allen who is also being honored today, and many other esteemed members of our Bar. He also enjoyed hunting and gardening and loved his dogs.

First and foremost, Robert Enders was a family man and he led with a gentle hand. He is greatly missed and revered by his five children, Janice Brunner of Lodi, NY, wife of Scott; Jennifer Ostman of Richmond, VA, wife of Dr. Henry; John L. Enders, of Margate, FLA; Robert A. Enders, Jr. of Eden, NC, husband of Bonita; and David G. Enders, of Halifax, PA, husband of Dianne, and his ten grandchildren and two great grandchildren. His love of family was evident as he led three generations of Enders in the title business. On a daily basis you would see Bob, his son, David, and grandson, Justin, working on title matters in the courthouse.

I am honored to present this resolution on behalf of my uncle, Robert A. Enders, Sr. He was a man of very few words and a gentle man with a big heart. My father shared office space with Uncle Bob when I was a young girl and I was able to observe my uncle's work ethic. In the fourth grade I wrote that I wanted to be an attorney at law. One of the influences guiding me was my observation of Uncle Bob at work, helping people with his kind and gentle demeanor.

Robert A. Enders, Sr. is missed by his office, the Office of the Recorder of Deeds, the Dauphin County Courthouse, Dauphin County generally, and, most importantly, in his home. He was a loyal friend, family man and colleague who brought honor to his profession.
