

## MARCH 17 PRO BONO CLE OFFERED

You are invited to attend "Expand Your Custody/Dependency Practice to Represent Immigrant Children and Their Caretakers," a CLE training on March 17 from Noon to 1:30 PM at the Dauphin County Bar Association. HIAS-Pennsylvania, with support from Stoneleigh Foundation, will present the training. The Luncheon will be available beginning at 11:30 AM.

Due to the great need for pro bono representation in this area, the CLE and lunch will be FREE for any attorney who has taken or is willing to take a pro bono case from HIAS or the Pa Immigration Resource Center.

Many children in Pennsylvania lack legal immigration status and are at risk of being separated from their caretakers, denied services, and forcibly returned to places where they will be exploited or abused. Some of these children can apply for legal immigration status because they are Special Immigrant Juveniles ("SIJs").

However, before children can apply for this special protection, they or their caretakers must obtain certain findings of fact, which can only be made by a state or county court, often in custody or dependency proceedings.

This training teaches attorneys who handle custody/dependency proceedings to represent SIJ-eligible children or caregivers in these contexts. After the training, HIAS will invite interested attorneys to develop their new skill by joining their team of lawyers who accept pro bono referrals in this niche area of family/child welfare law. The training will cover:

1. Who is eligible for SIJ classification

2. How to represent SIJ-eligible children/caretakers in Dauphin County

3. Common court concerns/Trouble shooting
