PA OFFICE OF OPEN RECORDS ("OOR") LAUNCHES AGENCY OPEN RECORDS OFFICER DATABASE

"PA Office of Open Records ("OOR") to launch Agency Open Records Officer Database

The Office of Open Records ("OOR") is launching a searchable, online database of Agency Open Records Officer ("AORO") contact information for every agency in the Commonwealth. The AORO database will allow the public to contact the correct AORO to request agency records and will ensure that the OOR can contact AOROs in the event an appeal is filed with the OOR. As part of the new online database, agencies can also update their AORO information online.

The OOR will launch the online AORO search function to the public on April 16, 2018. Prior to the launch date, the OOR is asking that all agencies review and confirm their AORO contact information at the following link: http://openrecords.pa.gov/AORO/

To review your agency's contact information, search your agency's name and click the edit icon next to your agency, then click submit. All emails associated with the account will receive a confirmation e -mail. Detailed <u>step-by-step instructions</u> are also available on the OOR's website. The OOR will review and confirm any changes within five business days.

AND THE SURVEY SAYS... YOUR PRO BONO WORK PROVIDES HOPE

Often, the area of greatest pro bono need is custody. Like many counties, Dauphin County Bar Association and MidPenn Legal Services offer monthly Pro Se Custody Clinics. For decades, the DCBA has hosted Clinics where pro bono attorneys help parents with the paperwork. At each two-hour Clinic, four to six pro bono attorneys help roughly 8 to 12 parents complete the custody court forms.

Five years ago, the Pro Bono Program launched Clinic Part 2 with the goal of helping parents better prepare for their Custody Conference. After a brief overview about the law, parents work with a small group of attorneys and other parents to review their custody situation and develop at least three schedule options. Other parents in the group are encouraged to play Devil's Advocate and offer suggestions as to why an option might not work.


