Serving Those Who Served

In January, the DCBA will launch an exciting new component to our existing Lawyer Referral Program entitled the Veterans' Disability Referral Service. I can think of no better time to outline this new program as Veteran's Day is less than two weeks away. As our country will soon honor our Veterans who served this great country and protected our freedoms, the DCBA, in two months will begin to provide attorney referrals to our local veterans whose service related disability claims have been denied, thus filling a void in Dauphin County that has existed since July 2010. In fact, our new Veteran's Disability Referral Service will be the only formal program in the entire Commonwealth to provide representation referrals to veterans seeking benefits for service connected injuries, illnesses and diseases before the Board of Veterans' Appeals.

The landscape of attorney representation in appeals before the Board of Veterans' Appeals changed in 2006. Prior to this time, an attorney could not represent a veteran appealing the initial denial of a disability claim. Legal assistance is critical at this point since the appeal process is complicated and can last four years or more.

In 2007, the Harrisburg campus of the Widener School of Law created the Veteran's Law Clinic based in large part on a three year grant. Jeremiah Underhill, the backbone of our new Veterans' Disability Referral Service, was hired to run the Widener Veterans' Law Clinic. This clinic provided legal representation to veterans appealing the denial of service related claims. Unfortunately, after three years the grant expired and the clinic ended. Through the hard work, persistence and dedication of many of our members including Brooks Foland, Stuart Knade, Brett Woodburn, Executive Director Liz Simcox and of course, Jeremiah, our new referral service is becoming a reality. And not a moment too soon as Dauphin County is home to over three thousand veterans.

In January, Jeremiah will occupy an office in our building a few days a week where he will review potential cases and meet with clients. Jeremiah's initial review of each case is not for claim viability, but rather to ensure that the appeal fits into the programs criteria and that the client meets the income threshold necessary for a referral. Our program will only provide a referral for a case that involves a denial of a veterans disability claim for a service connected injury, illness or disease. Once Jeremiah confirms that the case is eligible for our program, he will make the referral to one of our members who has agreed to participate and has been certified. Our normal fee for a member to participate in the Lawyer Referral Service will be waived for all veterans' disability referrals.

How do you get involved? The first step is to get certified, which is a relatively easy process that involves online registration and attending an orientation session at the DCBA or other approved CLE veterans law provider in person or online. Once a member is certified, all you need to do is complete a referral form which will be distributed to the membership in the coming weeks. Once the referral is made, Jeremiah will be available to answer questions about the appeal process before the Board of Veterans' Appeals. Also, please put Tuesday, December 3, 2013 on your calendar as there will be an official launch of the Veteran's Disability Referral Service at the DCBA beginning at 5 p.m.

In closing, I would like to thank Jeremiah, Liz, Brooks, Stuart, Brett and all of our members who have been instrumental in creating this exciting new program that will provide vitally needed representation to low income veterans in desperate need of service related disability benefits. I hope that you will take advantage of this unique opportunity to serve those who have served us at great personal cost – it will most certainly be a rewarding experience.

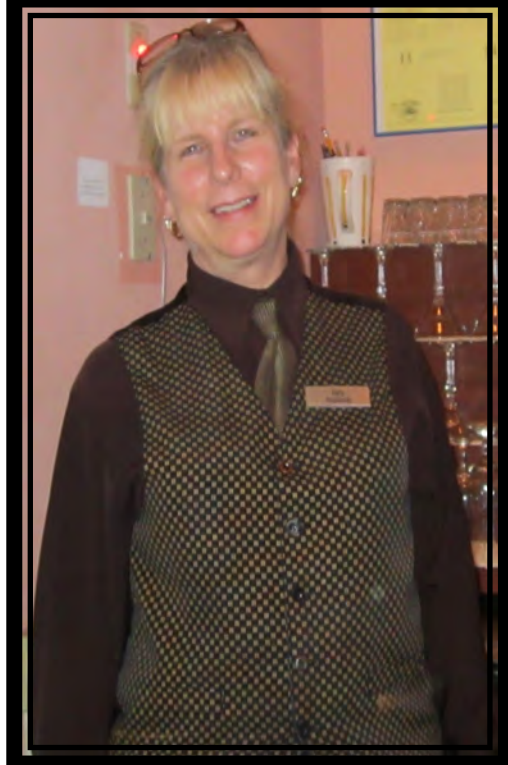

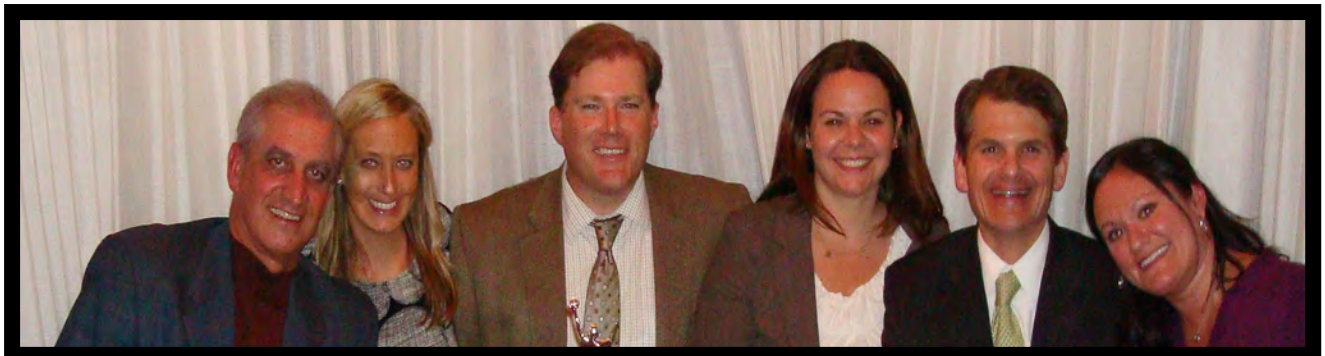

President Judge Hoover Hosts Reception for the Dauphin County Bar Foundation's Successful Custody Attorney Campaign: We Care About Children

Dauphin County Commissioners Present \$25,000 Boost to Fund Custody Attorney to Handle 150+ Custody Cases a Year for 5 years

When: Tuesday October 15, 2013, 5 PM – 6:30 PM

Where: Dauphin County Courthouse, 101 Market Street, 4th Floor Lawyer's Lounge, Harrisburg, PA

What: Nearly 35,000 people live below the poverty level in Dauphin County. To address an overwhelming demand for legal services in the area of family law the Dauphin County Bar Foundation raised funds to support a dedicated Custody Attorney position at the Harrisburg office of MidPenn Legal Services which provides free legal aid to the poor in civil cases.

Since December of 2010 the Custody Attorney has handled 494 custody cases and helped 1264 people. Economic stress has families under serious pressure. Orderly resolutions through court provide family members with a clear roadmap to follow. Stable families make stable communities.



Case story: Phaon is a very intelligent 13 year old boy who was named for his grandfather. He loves to visit the Gettysburg battlefield and his mother says he knows enough to apply to be a tour guide. But even though he was in the gifted program at Williams Valley Elementary School he was suddenly missing school.

Phaon's mother and father had separated five years ago and originally an agreement was worked out with mom having primary custody. But whenever Phaon was disciplined the father would offer to pick him up, eroding her parenting. Phaon moved back with his father but it was not as rosy as it seemed. When living with his father the boy's school attendance fell off dramatically and his schoolwork was affected.

The MidPenn Custody Attorney, Shana Walter represented mom at a modification hearing and Phaon was back in his mother's care and back on track at school. Phaon has regular visitation with his father.

MidPenn Custody Attorney Shana Walter and Doreen and son Phaon all have something to smile about .

Even smart kids need to stay in school. Phaon, named for his grandfather, is in the gifted program at Williams Valley Elementary School. He loves to visit the Gettysburg battlefield and his mom, Doreen Thomas, of Halifax, says that he could be a tour guide. He was getting great grades but then he missed a lot of school and failed sixth grade. How could this happen?

Phaon's mother and father had separated five years ago and originally mom had primary custody. But when Phaon was disciplined, dad would pick him up, eroding mom's parenting. Phaon moved back with his father but dad was hard pressed to be a full time parent. It was while living with him that Phaon's attendance fell off dramatically.

The MidPenn Custody Attorney, Shana Walter, whose position is funded by the DCBF campaign, represented mom at a modification hearing and Phaon is now back living with his mom and back on track at school. Phaon has regular visitation with his dad.

At an October 15 reception at the Lawyer's Lounge to honor the donors, President Judge Hoover said, "These are the hardest cases for judges. Our decision will impact these families for a long time. Family law has the sharpest increase in demand for service. In 2010 the number of cases being sent to the conference officers exceeded 1000 for the first time. In 2011 the number was 1115 and in 2012 increased to 1208. We so appreciate the support of the Dauphin County Commissioners and Metro Bank and all the donors to this wonderful effort."

Other lead donors to the effort include Capital Blue Cross; Citizens Bank; McNees, Wallace & Nurick; Rhoads & Simon, and the Wells Foundation. The campaign is just \$5,500 short of its five year goal of \$325,000. Think kids matter? Join the team and send a check to the DCBF. Our campaign slogan is simple: We Care About Children.

Dear Members of the Dauphin County Bar Association,

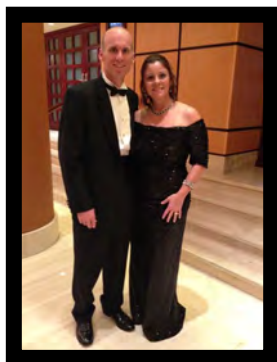

NATIONAL PRO BONO WEEK

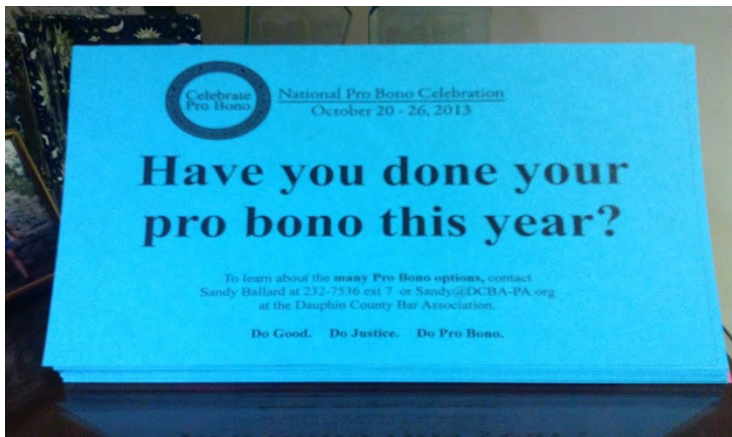

As you may know, our Dauphin County Bar Association administers a Pro Bono Program with MidPenn Legal Services. Pursuant to a resolution adopted by the membership, each member is asked to participate in the pro bono program annually.
